## INTRODUCTION

The cultural association "architect Simonetta Bastelli" aims to promote the culture of qualified landscape and the landscape in the collective commons, with a particular attention to the new generations, in an proper relationship between architecture and nature. Due to this aim, the city of San Venanzo, organize a Workshop at the old city of Poggio Aquilone, which responds at the principles of the association "architect Simonetta Bastelli" concerning landscape enhancement and the relationship between architecture and nature.

The workshop is about an urban regeneration of a site in the city of San Venanzo. The aim of the workshop, according with the Art.6 of European Landscape Convention, is to increase awareness among the civil society, private organizations and public authorities regarding the value of landscapes, their role and their transformation" and contribute to "training and education" with a proper design methodology. A special jury, composed by of representatives of the municipal administration, universities and professional associations, with the participation of international experts, will select the best project.

## Art. 1 – THE COMPETITION

The cultural association "architect Simonetta Bastelli" announces the selection for the participation at the workshop in Poggio Aquilone, San Venanzo (TR) during the month of September 2019.

## Art. 2 – THEME AND ORGANIZATION

The permanent workshop is open to 20 participants and will be held at the ancient village of Poggio Aquilone in San Venanzo from September 17 to September 20, 2019. Participants will work on a specific theme related to the connection between Architec-

Participants will work on a specific theme related to the connection between Architecture and Nature.

The theme for the 2019 edition will be "the recovery of minor historical centers". The intervention area, within the municipality of San Venanzo, will be that of the ancient village of Ripalvella, with particular attention to the square. Participants will be divided into working groups, each coordinated by a tutor. In addition to the coordination of the tutor, the project work takes place in a confrontation with international personalities in the various operating sectors of the landscape.

#### **Art. 7 – ORGANIZATIONAL ASPECTS**

The organization will deliver the analytical material needed for optimal performance of the workshop before the event.

Organized groups will work on the spot with their tutor, and will develop the project idea in 3 A2 size boards.

The material must be delivered to the organizing secretary of the workshop before 17:00 of Friday, September 20, 2019.

At 9 o'clock a.m. of September 21, 2019 every group will present its proposal, in front of the commission and the other people who will attend the conference.

#### Art. 8 – JURY

The elaborated projects will be analyzed by a special jury that will choose the deserving ones of award and any mention. The jury will be composed of representatives of the municipal administration, universities and professional associations, with the participation of international experts.

It will be composed of at least seven members and will be valid if it will attend the absolute majority of the members.

The jury shall elect a president and will decide independently the judgment. The judges' decision is unquestionable.

#### Art. 9 - AWARDS

The awards will take place on September 21, 2019. The tutor of the winning group will receive a plaque, a special prize will go to the members of the winning group and the



members of the mentioned groups will receive a diploma prizes and some special prizes offered by the sponsors.

There are no money prizes.

## Art. 10 – EXHIBITIONS AND PUBLICATIONS

The projects developed during the workshop will be exhibited and presented on the meeting during the Conference.
